MALL AND VICINITY

Theft from Vehicle – Bally’s, 256 Mall Blvd: Occurred on 2/23/08 between 1645-1822 hrs. A purse which was left on the front seat was stolen and the credit cards were used at several locations prior to being reported stolen.
