MALL AND VICINITY

THEFT OF VEHICLE:

King of Prussia Plaza: Occurred 02/23/2007 between 1600 and 1830 hours. An unknown person removed a 2005 Dodge Ram R15 truck that was parked in the area of pole 5A.

THEFT - KING OF PRUSSIA PLAZA: Occurred 02/24/2007. Victim reports an unknown person removed her Prada wallet, containing \$130 cash, while she was walking between the Ruby's Restaurant and the Sweet Factory.

THEFT FROM & MISCHIEF TO VEHICLE:

Fox & Hound Pub & Grille: Occurred 02/24/2007 between 1900 and 2210 hours. An unknown person smashed the rear side window on a 2007 black Lexus GX470 and removed a Compaq laptop computer.

THEFT - UNITED ARTISTS THEATER/ IMAX: Occurred 02/24-25/2007 between 2200 and 0001 hours. Victim reports that while in the movie she had placed her purse next to her during that time. After she left the movie she realized she had misplaced her purse. She returned to check the area and could not locate it; however, when she called to cancel her credit cards she was informed that they were already used at various locations.
