Mall and Vicinity

Criminal Mischief to Vehicle – East Garage: Occurred on 07/14/07 between 1230-1600 hrs. A window was broken out of a blue 2006 Toyota Prius.

These suspects were able to obtain debit card information and PIN numbers for over 100 victims and stole upwards to \$200,000.00 using ATM's in PA, NJ and DE. A total of three suspects were arrested and charged in these crimes.
