MALL AND VICINITY

Criminal Mischief to Vehicle – West Garage, Level 1 1/2 K: Occurred 9/19/07 between 1400-2200 hrs. An unknown person broke off side view mirror of a black 2003 Volkswagen Jetta.

Thefts from Vehicles – Plaza Area: Occurred between 09/28/007 and 10/04/07. Sixteen vehicles were broken into and GPS systems and/or laptops were stolen. The vehicles were parked in the follow areas: Pole 40B, Pole 42B, Ruth Chris Steak House, Champps, Sullivan's Steakhouse, Bahama Breeze, Holiday Inn Express, Fox and Hound.
