Upper Merion Police Officers responded to 546 calls for service including 38 automobile crashes, 6 Retail Thefts, 8 domestics, 11 disabled vehicles, 10 meet complainants and 35 alarms. Some notable incidents from the same are detailed below:

MALL AND VICINITY
