UPPER MERION TOWNSHIP POLICE

Upper Merion Police Officers responded to 517 calls for service including 23 automobile crashes, 8 Retail Thefts, 7 domestics, 8 disabled vehicles, 20 meet complainants and 48 alarms. Some notable incidents from the same are detailed below:

MALL AND VICINITY
