WEEKLY BULLETIN

For the week ending on **April 20, 2017**

Upper Merion Police Officers responded to 564 calls for service including 29 automobile crashes, 8 Retail Thefts, 4 domestics, 14 disabled vehicles, 12 meet complainants and 53 alarms. Some notable incidents from the same are detailed below:

MALL AND VICINITY

Retail Theft

Solstice Sunglass Boutique 160 North Gulph Road – occurred 4/12/17 at 1340 hours

An unknown male was captured on security camera stealing three pairs of sunglasses.

Theft Report

Swarovski Crystal Storage 160 North Gulph Road – occurred between 4/11/17 4/13/17

An unknown actor broke into a fixture supply room (not intended to store merchandise) and stole 186 Chrystal items.
