WEEKLY BULLETIN

For the week ending on **February 9, 2017**

Upper Merion Police Officers responded to 467 calls for service including 27 automobile crashes, 10 Retail Thefts, 4 domestics, 7 disabled vehicles, 9 meet complainants and 33 alarms. Some notable incidents from the same are detailed below:

MALL AND VICINITY

Burglary Report

Costco Wholesale 201 Allendale Road – occurred 2/6/17 at 0051 hours

UMPD received a security alarm for the location. On arrival officers found that an unknown actor gained access to the roof and entered the building after breaking through a skylight. The actor repelled to the floor where jewelry was taken from a display case. The actor then exited via the rear door toward the PA Turnpike.

Terroristic Threats
