Upper Merion Police Officers responded to 477 calls for service including 25 automobile crashes, 7 Retail Thefts, 11 domestics, 6 disabled vehicles, 14 meet complainants and 28 alarms. Some notable incidents from the same are detailed below:

## MALL AND VICINITY

### **CCCF**

#### Morton's Steak House 640 W. DeKalb Pike – occurred 07/01/17 at 1900 hours

An unknown male was seen on security video stealing a wallet from within an employee's purse which was stored near the mall entrance to the restaurant. The actor was accompanied by another male and female. The trio used the victim's credit at Bloomingdale's.

#### **Overdose**

Officers responded to location and found a male in a vehicle, unconscious from an apparent heroin overdose. Officers administered Narcan which revived the male who was then transported to Suburban Community Hospital.
