

# UPPER MERION TOWNSHIP POLICE



## WEEKLY BULLETIN

For the week ending on July 20, 2017

Upper Merion Police Officers responded to 564 calls for service including 29 automobile crashes, 8 Retail Thefts, 10 domestics, 6 disabled vehicles, 3 meet complainants and 36 alarms. Some notable incidents from the same are detailed below:

### MALL AND VICINITY

#### Overdose

**Wegman's Market 1 Village Drive – occurred 7/17/17 at 2340 hours**

A female used an Uber to travel from her home in North Wales to Philadelphia where she purchased heroin. During the ride back she asked the driver to stop at Wegman's to use a clean bathroom. The female was then initially found unconscious in the bathroom from a heroin overdose, but later regained consciousness and was transported to the hospital.

#### Retail Theft

**Shinola 350 Mall Blvd – occurred 7/19/17 between 1630 and 1700 hours**

An unknown male and female were seen on security video stealing three watches and leaving the store.

#### Theft Report

**King of Prussia Plaza Connector 350 Mall Blvd – 7/13/17 between 1008 and 1030 hours**

A mall employee mistakenly left her wallet in the public restroom in the Mall Connector. Security video shows that a housekeeper was the only person to enter the restroom before the wallet was confirmed missing. The housekeeper was charged with the theft.
