WEEKLY BULLETIN

For the week ending on **June 15, 2017**

Upper Merion Police Officers responded to 567 calls for service including 34 automobile crashes, 7 Retail Thefts, 10 domestics, 9 disabled vehicles, 13 meet complainants and 42 alarms. Some notable incidents from the same are detailed below:

MALL AND VICINITY

Burglary in Progress

Joe's Crab Shack 244 Mall Blvd – occurred 6/13/17 at 0055 hours

Officers responded for an alarm activation at the front patio doors and found a subject inside the bar area with a bag of tools. The male claimed that he was allowed in by an employee. A manager responded and refuted his story and he was taken into custody.
