WEEKLY BULLETIN

For the week ending on **June 29, 2017**

Upper Merion Police Officers responded to 602 calls for service including 33 automobile crashes, 9 Retail Thefts, 9 domestics, 8 disabled vehicles, 12 meet complainants and 46 alarms. Some notable incidents from the same are detailed below:

MALL AND VICINITY

CCCF

Grand Lux Cafe 160 North Gulph Road – occurred 6/27/17 between 1738 and 1830 hours
An unknown female was seen on security video stealing a wallet from within an elderly woman's purse as it hung from the back of her chair. The victim's credit cards were then used for several hundred dollars' worth of purchases in the mall.

Pedestrian Stop

Lord and Taylor 180 North Gulph Road – occurred 6/22/17 at 1424 hours
Officers responding to Wawa, 196 South Gulph Road for a second report of two subjects causing a disturbance, police located the two subjects. One was uncooperative and was taken into custody for Disorderly Conduct. The other who was found to be wanted, fled on foot and was apprehended in the parking lot of the Plaza.
