# WEEKLY BULLETIN

### For the week ending on March 16, 2017

Upper Merion Police Officers responded to 460 calls for service including 32 automobile crashes, 3 Retail Thefts, 5 domestics, 14 disabled vehicles, 6 meet complainants and 52 alarms. Some notable incidents from the same are detailed below:
