Upper Merion Police Officers responded to 538 calls for service including 30 automobile crashes, 2 Retail Thefts, 9 domestics, 13 disabled vehicles, 11 meet complainants and 35 alarms. Some notable incidents from the same are detailed below:

MALL AND VICINITY
