# WEEKLY BULLETIN

### For the week ending on May 4, 2017

Upper Merion Police Officers responded to 582 calls for service including 31 automobile crashes, 5 Retail Thefts, 6 domestics, 8 disabled vehicles, 10 meet complainants and 38 alarms. Some notable incidents from the same are detailed below:

# MALL AND VICINITY

### **Theft Report**

### Loft Store 160 North Gulph Road – occurred 4/22/17 at 2010 hours

An unknown actor stole a wallet which was on a shelf in the fitting room as the owner tried on clothes.

### Wegman's Market 1 Village Drive – occurred 4/28/17 at 1648 hours

An unknown actor (possibly a female) stole a purse from the back of a child's stroller as the owner loaded groceries into her car.

### Royal Bank 655 West DeKalb Pike – occurred 4/27/17 at 1224 hours

A W/M (late 30's, thin build, 5'6, thick shaggy hair to the collar with long bangs, full beard, glasses, wearing a suite with sneakers and black gloves) walked across Route 202 at 1218 hours from the Court parking lot. He then walked into the bank, approached the manager, implied that he had a weapon and demanded cash. The male then approached the teller's counter where he placed cash and a dye pack into a small brown paper bag with handles, which he brought into the bank with him. He then fled on foot, northbound, across DeKalb Pike toward the Court. He was last seen running into the second level of the "Blue Parking Garage" near Macy's.

The caller may also ask you to not contact their parents or other family members regarding this situation as they are either embarrassed or don't want to alarm them. If any money is sent it will be lost. So please check into the situation before sending any money. Contact the family member and verify with them that they are alright.
