UPPER MERION TOWNSHIP POLICE



For the week ending on **September 14, 2017**

Upper Merion Police Officers responded to 517 calls for service including 22 automobile crashes, 9 Retail Thefts, 6 domestics, 11 disabled vehicles, 8 meet complainants and 30 alarms. Some notable incidents from the same are detailed below:

MALL AND VICINITY

Retail Theft

Toys R Us / Babies R Us 250 Mall Blvd – occurred 9/10/17 at 1813 hours

The store recently installed an anti-theft system that will lock the wheels of a shopping cart that does not go through the check and an alarm sounds at the front door. The manager stated the alarm sound and he observed a male dragging a shopping cart through the parking lot. The manager did not confront the male, miscellaneous baby items were taken. The male left in a silver Ford.

Terroristic Threats

The manager called to document a verbal argument that occurred between two employees over a conflict concerning who was waiting on a specific table. One employee said he was "going to shoot the other". The manager terminated the employee who made the threat.

Theft in Progress

Overdose
