UPPER MERION TOWNSHIP BOARD OF SUPERVISORS JULY 10, 2014

The Board of Supervisors of Upper Merion Township met for a Business Meeting on Thursday, July 10, 2014, in Freedom Hall, in the Township Building in King of Prussia. The meeting was called to order at 8:04 p.m., followed by a pledge to the flag.

ROLL CALL:

Supervisors present were: Greg Philips, Erika Spott, Greg Waks, Bill Jenaway and Carole Kenney. Also present were: David Kraynik, Township Manager; Sally Slook, Assistant Township Manager; Andrew Olen, Solicitor's Office; Angela Caramenico, Assistant to the Township Manager.

MEETING MINUTES:

It was moved by Mr. Philips, seconded by Mrs. Kenney, all voting "Aye" to approve the May 1, 2014 Workshop Meeting Minutes, May 8, 2014 Joint Meeting Minutes, May 15, 2014 Business Meeting Minutes, June 5, 2014 Special Meeting Minutes, and June 5, 2014 Workshop Meeting Minutes as submitted. None opposed. Motion approved 5-0.

CHAIRPERSON'S COMMENTS:

Chairperson Waks stated an Executive Session was not held prior to this meeting. He noted the business meeting was delayed because of the second annual Board of Community Assistance awards ceremony which was held prior to this business meeting.

NEW BUSINESS

Chief Nolan stated there are two promotions due to the pending retirement of Sergeant Andy Andreyko and these promotions will take effect on July 26, 2014 at 4 p.m. Promotions are based on a most recent eligibility list which was established after a comprehensive testing and evaluation process.

Mr. Waks announced a number of upcoming Township meetings and events. He also reported on the tragic "hit and run" accident that occurred on July 5th in the vicinity of the King of Prussia Mall. The Upper Merion Police Department is seeking witnesses to this incident.

Mr. Waks also noted a workshop meeting will be held in the Board Room after this business meeting. The next Board of Supervisors workshop meeting will be held on Thursday, July 31st at 6 p.m. in the Board Room. In addition, Upper Merion Day will be held at the Elmwood Park Zoo. All admission is half off. Proof of Upper Merion residency will be necessary.

BOARD OF COMMUNITY ASSISTANCE

Mr. Waks reported on the 2nd annual Board of Community Assistance awards that were presented prior to this business meeting. Over \$150,000 went to organizations which help Upper Merion residents and scholarships for Upper Merion high school seniors entering college and trade school. Mr. Waks expressed appreciation to the members of the Board of Community Assistance for their service in reviewing the significant number of applications for grants and scholarships. Mr. Waks read a letter he received on behalf of the members of Board of Community assistance from a student at Temple University, Jessie Bereda who received a scholarship last year and made the Dean's List for the Spring 2014 semester.

Mr. Waks stated in a few months the open period for 2015 scholarships and organizations will begin and he encouraged any organization providing services to Upper Merion residents and any graduating high school senior who residing in Upper Merion township should apply for a scholarship.
