# UPPER MERION TOWNSHIP BOARD OF SUPERVISORS REORGANIZATION MEETING JANUARY 4, 2016

The Board of Supervisors of Upper Merion Township met for a Reorganization Meeting on Monday, January 4, 2016, in Freedom Hall, in the Township Building in King of Prussia. The meeting was called to order at 7:35 p.m., followed by a pledge to the flag.

### PROCLAMATION RE: MARTIN LUTHER KING, JR. FEDERAL HOLIDAY

After reading the Martin Luther King, Jr. proclamation, Mr. Jenaway presented the proclamation to David Broida, who accepted the proclamation on behalf of the Martin Luther King Committee. Mr. Broida thanked the Board of Supervisors for their support and participation of the Martin Luther King celebration in Upper Merion Township. Mr. Broida encouraged attendance at this year's program to be held on Wednesday, January 13, 2016 at 7 p.m. at the Upper Merion Middle School.

# ADDITIONAL BUSINESS:

Mr. Jenaway reviewed the highlights of what has been accomplished in Upper Merion Township over the past year as posted on Greg Waks' website.

- Trail opened from Heuser Park to Valley Forge National Historical Park.
- Township assumed responsibility for the pool and made significant safety improvements
- Substantial progress on public and private construction projects including the Upper Merion Community Center, the King of Prussia Mall Connector, and the King of Prussia Town Center/Village at Valley Forge.
- First senior housing approved in Upper Merion Township and this R-55 type community should be open in about two years.
- An electronic sign was installed at the township building to provide residents with additional information about happenings in Upper Merion Township as well as emergencies.
- The Board of Community Assistance once again disbursed over \$150,000 in grants to local organizations which provide services to Upper Merion residents and scholarships to graduating high school seniors who reside in Upper Merion Township.
- For the 6<sup>th</sup> consecutive year we did not raise taxes the longest such stretch in decades and Upper Merion maintained its AAA bond rating.
- Our unemployment rate is extremely low at approximately 3.5%.

It was noted 2016 should be one of the biggest years in recent Upper Merion history. Highlights of what is anticipated:

- Ribbon cuttings for the new community/senior center, the King of Prussia Town Center, IFLY Indoor Skydiving, King of Prussia Mall Connector, Sullivan's Bridge and portions of the Village at Valley Forge.
- The relocation of the Park and Recreation offices to the new community center.
- Continued presentations from SEPTA regarding the potential extension of the Norristown High Speed Line
- The Municipal Utility Authority responsibilities possibly being expanded to include stormwater management
- The Village at Valley Forge will begin construction of senior housing and townhomes.
- The KOP District will begin construction of the First Avenue Linear Park.
- Repairs to the Keebler Road Bridge
- The former Sports Authority will be transformed into a larger state liquor store with a bar for tastings and food pairing events, a Stein Mart and a Fortunoff Outdoor Furniture Store.
- Groundbreakings for the Route 422 bridge project and the extension of the Chester Valley Trail.
- Continued progress on the Daniel T. Kellett Memorial Skate Park.
- As part of effective long term planning for Upper Merion, the updating of the community Master Plan, the unveiling of the new Park and Recreation Master Plan and a Fire and an Emergency Services Study which will probably have some impact on the future of fire and rescue services in the township as it continues to grow.

Mr. Jenaway noted the number of vacancies on township authorities, commissions and boards and encouraged those interested in volunteering to submit an application.

Mr. Jenaway also reiterated the commitment of the Board of Supervisors to remain visible around the community and constantly communicate with residents with the various communication resources available in the township such as the township's electronic LED sign, social media (including Facebook and Twitter), UMGA-TV, the weekly and quarterly publications and accessibility via email.

Mrs. Spott expressed appreciation for the honor in serving as Chairperson of the Board of Supervisors for the past year. She thanked Dave Kraynik, Township Manager, and the township staff for their professional expertise and competent execution of the Board's policies and directives.

### UPCOMING MEETINGS AND ANNOUNCEMENTS

Mr. Jenaway announced a number of upcoming Township meetings and events.
