ENGINEER'S REPORT

Relocated North Gulph Road, SR 0023 Section 2NG (Including Granite Block Restoration at Valley Forge Monument)

Mr. Smyth stated a virtual progress meeting will be scheduled for July. Continued progress with the Utility Clearances. The 4F approval by the Highway Administration has been completed and is getting close to the point of reevaluation is submitted and under formal review by PennDOT's Environmental Unit. Once this is in place, the Federal Land Transfer process can begin. Comments were addressed on the Safety Review that was submitted were received in regards to the Gulph Road granite blocks

SR 0023, Section TCB - PA Trout Creek Bridge

Mr. Smyth stated there was follow up coordination that PennDOT required on the Safety Review submission. The Final Design contract was advertised and PennDOT has not selected on the consultant who will be doing final design services.

Church Road Bridge over SEPTA Route 100 Line

Mr. Smyth stated the PS&E Package was submitted to PennDOT for Contract Management Review in the middle of April. Gannett Fleming on behalf of PennDOT, asked Mr. Hiriak to provide the Construction Inspection Staffing Letter which is a formal component that is required and BSA is helping.

Glasgow Development Team submitted the request for an absolution on the Traffic Impact Fee assessment. The assessment itself is calculated by McMann and Associates and was approximately \$667,000.00. Hickory Courts (PCS) contacted the Township this week and they conducted bridge inspections on behalf of PennDOT and they have inspected three local bridges. These are boxed culverts that are side by side that are now classified as bridges. The paving program was awarded to Allen Myers last month and scheduling a preconstruction meeting is in the process for street paving dates. Public Work's crews will be performing cleanup for the next few weeks and will be picking up anything residents bring up to the curbside.

FINANCIAL REPORT

Mr. Hiriak reported he is working with Alexa from Gannett and Fleming to get all the documentation to UCMS. A final audit report should be issued next month. Mr. Hiriak stated the audit went very well with no issues to report.
