The Board of Supervisors of Upper Merion Township met for a Reorganization Meeting on Monday, January 6, 2014, in Freedom Hall, in the Township Building in King of Prussia. The meeting was called to order at 7:38 p.m., followed by a pledge to the flag.

# **SNOW REMOVAL**

Mr. Philips recognized the work of the Public Works staff for their snow removal efforts during the recent snow storms in our area.

## DANGEROUS TEMPERATURES

Mr. Philips urged citizens to check on their older neighbors and those with health issues during these extreme cold weather conditions.

## **SWEDESBURG FIRE COMPANY**

Mrs. Spott extended an invitation for the public to attend the Friday Night Grille hosted by the Swedesburg Fire Company on January 10 and 24. She reminded and encouraged citizens to support local businesses and fire companies.

## HISTORICAL REFLECTION

Mrs. Spott offered a reflection on a former public figure and television personality who was known for his advocacy of community involvement and various public causes and was a particular inspiration to her as a child – Mr. Rogers. She recognized our local heroes such as volunteer fire departments, volunteer EMS, youth sports coaches as well as the township's own citizen board members who give of their time and talent. Mrs. Spott commented the recent election is a reminder that anyone, win or lose, who "throws their hat in the ring" is to be commended for accepting the challenge to serve their community.

## WINTER FARMERS MARKET

He indicated the BCA receives funds from the Valley Forge Casino Resort as part of an agreement with the township, and applications can be found on the township website.

# ALLENDALE ROAD BRIDGE WORK

Mr. Waks stated repair work will begin on the Allendale Road Bridge on January 15<sup>th</sup>. He indicated the segment of road from Wills Boulevard to US 202 will be one-way for up to six months. Mr. Waks emphasized how vital this bridge is to Upper Merion Township, the local economy, our transportation structure, and public safety services.
