1) <u>Update on Land Development Plans</u>

Mr. Kraynik reported that Schultz Enterprises on 541 Flint Hill Road is looking to construct a 40,000 sf, 1-story for recreational use and warehousing. They also want to put in a 116- spaced paved parking lot. This would result in \$275,000.00 tapping fees for the Authority.

- ▶ Mr. Kraynik advised Brandywine building renovation at 500 N. Gulph Road wants to add an additional 2,000 sf additional office space with a one-level parking deck. This would result in \$16,000.00 in tapping fees for the Authority.
- Mr. Kraynik advised that Workhouse Brewer on 250 King Manor Drive will be an 18-room, 132 parking space brew house with a tasting room that will result is roughly \$137,000.00 in tapping fees for the Authority.
