Upper Merion Police Officers responded to 633 calls for service including 36 automobile crashes, 9 retail thefts, 8 domestics, 13 disabled vehicles, 18 meet complainants and 60 alarms. Some notable incidents from the same are detailed below:

# MALL AND VICINITY

# **Retail Thefts**
