For the week ending on April 19, 2018

Upper Merion Police Officers responded to 607 calls for service including 45 automobile crashes, 9 retail thefts, 5 domestics, 9 disabled vehicles, 19 meet complainants and 37 alarms. Some notable incidents from the same are detailed below:

MALL AND VICINITY

Retail Thefts

Two female actors filled 3 bags with merchandise and ran out of the store- fleeing the area in a grey Pontiac sedan.
