For the week ending on May 3, 2018

Upper Merion Police Officers responded to 643 calls for service including 33 automobile crashes, 7 retail thefts, 5 domestics, 9 disabled vehicles, 19 meet complainants and 44 alarms. Some notable incidents from the same are detailed below:

MALL AND VICINITY
