## **Electric Car Charging Stations**

#### **Roof Repairs**

Roof repairs to stop water infiltration coming through Library windows during wind-blown rains were not entirely successful. Remington, Vernick and Beach are soliciting quotations for sealing around those windows. Building maintenance staff are doing some internal repair work for some of the water damage.

Authority members asked for additional clarification about the water infiltration. Mr. O'Brien responded subsequent to the roof installation there were annoying water leaks. Remington, Vernick put out a bid and miscellaneous concrete repairs were made to the roof and parapets a few months ago. This repair work did not entirely stop the water which was the intent of the whole project. After further examination and the process of elimination it was determined during wind-blown rain the water enters into the recesses on the library side of the building. The window seal needs to be replaced all along that side of the building. Quotations to stop the water penetration are being solicited through PennBid so that it will not be necessary to go out for bid.
