Upper Merion Police Officers responded to 612 calls for service including 41 automobile crashes, 8 retail thefts, 6 domestics, 15 disabled vehicles, 13 meet complainants and 39 alarms.

Some notable incidents from the same are detailed below:

MALL AND VICINITY
