  - 2. Maintain parks to the best of the Park & Rec Board's ability continue to support and advertise the Adopt-A-Park program. David Burns is going to work on creating a plan.
  - 3. Trail completion.
  - 4. Community Center / Pool.
  - 5. Put WiFi in parks Heuser & Walker/security cameras at parks.
  - 6. Watch dollars for Fees "in Lieu of".
  - 7. Open organizations to young people with special needs (adaptive sports programs) especially organizations the township gives grant monies to.
