SOLICITOR'S REPORT

Borough of Bridgeport-Deed of Easement

The Borough of Bridgeport-Deed of Easement has been executed and recorded. A copy was mailed to the Executive Secretary.

LeBus - Update

At the previous meeting the Authority was informed that the MIPP Administrator and Solicitor met with EPA (Environmental Protection Agency) to discuss the violations concerning LeBus. LeBus is required to file a proposal consent order by the end of July. The MIPP Administrator and an EPA representative have continued to inspect the LeBus property and encountered additional concerns. All parties have been advised of these new concerns, primarily the attorney for LeBus.

Whitegate Easement

Whitegate Easements have been executed and recorded. Original copies have been sent to the Authority.

Tredyffrin Agreement – Pine Hill / Matsunk Agreement

Revisions of the 1970 Tredyffrin Service / Matsunk Agreement have been completed. The Engineer worked closely with the Solicitor correcting and revising the Agreement to read as the 1989 Major Agreement with Tredyffrin for Trout Run. The previous Tredyffrin /Matsunk Agreement expired in 2010 and an extension was implemented. The Solicitor and

Super Wawa and Chick Filet will be constructing their stores in the area where PETCO was previously located, on Route 202.

Henderson Road Sewer Lines

Bids for the extension of the sewer line down Henderson Road were opened. Abenizio was awarded the contract. The final paperwork from PaDEP for the Amendment to the 537 plan is progressing. All reports have been received and a "Notice to Proceed" will be forthcoming.

Hotel Sierra and Joe's Crabshack

Construction of the Hotel Sierra and Joe's Crabshack are moving forward.

Casino

The demolition permit has been issued. After the existing structure is assessed and removed the construction permit will be finalized and designs will be drafted. The Casino started demolition, and by the end of August will attempt to have a final design plan prepared for implementation. Project is scheduled to begin March 2012.

Kravco

Kravco will demolish and remove the Wanamaker building, reconfigure the front of the stores in that area, and add a large store that will occupy 60,000 square feet accommodating 2 levels. The existing entry way will be renovated and showcase a grand entrance.
