LeBus

The conference call between EPA, the Township, the Solicitor, and MIPP Administrator was held today (*Tuesday, January 17, 2012*) and the concluding factor was to allow LeBus to respond to the settlement agreement drafted by the solicitor's office on behalf of the Authority by Tuesday, January 31, 2012. LeBus has not responded to the previous proposal submitted to them in October. It has been noted that LeBus was not in compliance for the months of October and November but were in compliance for the month of December.

Gannett Fleming (Engineering Firm representing Tredyffrin)

The Consulting Engineer is awaiting a response from Gannett Fleming about the fairness and accuracy of the costs related to the Township's portion of the Matsunk Plant Capital repair work and how they will proceed.

EXECUTIVE SECRETARY

Realen / Valley Forge

Plans have been submitted for Wegman's stand-alone restaurant which will create additional flow. The Executive Secretary was contacted by the Water Company requesting information about the thousand gallon rate. They were informed that they should add 6 percent to the \$1.87 per thousand gallons (*same as 2011*). Operation costs will commence when the flow begins out of the Valley Forge property.

Target

Target plan is in the land development phase and the net increase in flow has not been decided on.

WaWa / Chick-Fil-A

WaWa / Chick-Fil-A plans are in the land development phase and an adjustment to the increase in flow will be made due to the addition of a restaurant.

Casino

The Casino has reached its goal with a Grand Opening date in March 2012.

Simon Properties, the new owner of the King of Prussia Mall is looking to make additional connections for future development usage.
