# **Upper Merion Township Police**



## For the week ending on May 17, 2018

Upper Merion Police Officers responded to 624 calls for service including 55 automobile crashes, 11 retail thefts, 8 domestics, 13 disabled vehicles, 15 meet complainants and 54 alarms. Some notable incidents from the same are detailed below:

## MALL AND VICINITY

#### **Retail Thefts**

#### **Solicitors**
