Meeting Minutes: May 23, 2012

Mr. Elgart, who was not present at the last meeting, abstained from voting on the approval of the Minutes for May 23, 2012. Mr. Sincavage motioned for their approval. Ms. Camp seconded. A 3-0 vote, in favor, carried.

Mr. Krutsick turned the meeting over to Scott Greenly, Associate Planner.

Workshop: Outdoor Lighting: Review of Montgomery County Planning Commission comments.

The following represent additions to the draft Outdoor Lighting Ordinance:

- The term "Luminaires" and its definition.
- The County's model language for the maximum height of light fixtures.

Mr. Elgart's recommendation to adopt the amended Lighting Ordinance was seconded by Ms. Camp. A 4-0 vote, in favor, carried.

Workshop: Commercial/Business Districts: Review of KOP BID recommendations.

Group discussion addressed the BID's boundaries; the physical constraints of the existing street network and building infrastructure; and the BID's recommendations for improving the Route 202 and First Avenue corridors.

Illustrations of the proposed improvements for the Route 202 and First Avenue corridors evoked conversations about:

- Traffic congestion.
- Pedestrian connections.
- Public transportation.
- Transit-oriented development.

Adjournment: There being no additional business, the meeting adjourned at 8:15 p.m.
