Mr. Greenly described SIMON Property Group's interest in acquiring responsibility for a 5,846 sq. ft. of public right- of-way for the purpose of installing underground utilities. Their original request of 7,000 sq. ft. was scaled back to allow for the potential need of a lane widening. Previously-planned and approved pedestrian-friendly amenities will head from Mall Boulevard toward the Mall. This request was reviewed by the County and Township's Transportation Engineer.
