Meeting Minutes: September 26, 2012.

Ms. Camp motioned for the approval of the Minutes of September 26, 2012. Mr. Krutsick seconded. Mr. Elgart, who was absent at the last meeting, abstained. A 2-0 vote, in favor, carried.

Plans:

Franklin Maps Carwash 333 S. Henderson Road DP 2012-08

Construction of a carwash, detail bay and pet wash station on existing Franklin Map property.

LI Limited Industrial, 4.01 Acres.

Present: Andrew H. Amsterdam, Proprietor, Franklin Maps, King of Prussia, PA.

Joseph M. Estock, PE, PLS, Joseph M. Estock Consulting Engineers &

Land Surveyors, King of Prussia, PA.

In response to County and Township reviews the applicant submitted a revised plan that proposes:

- Two access lanes and one exit lane to improve circulation.
- Stacking for 13 cars and an auxiliary lane for 5 more, for a total of 18.
- A reduction of three feet in the building's width.
- A reduction of eight feet in the building's length.
- A white line and stop bar at the carwash building's exit.

The applicant received a variance from installing a sprinkler system.

From group discussion:

- Each carwash takes about 5 minutes.
- A detailing bay with three parking spaces may be added in the future.
- An area in the back of the property is parking space for a snowplow.
- Nine carwashes from the same manufacturer, with stacking ranging from 3 to 11, exist across the US.

The improved plan was viewed as an elegant solution.

Mr. Elgart recommended approval of the revised plan. Ms. Camp seconded. A 4-0 vote, in favor, carried.

Mr. McKee made a motion to approve the Outdoor Lighting Ordinance. Ms. Camp seconded. A 4-0 vote, in favor, carried.
