

# Upper Merion Township Police



## Weekly Bulletin

**For the week ending on May 24, 2018**

Upper Merion Police Officers responded to 671 calls for service including 41 automobile crashes, 6 retail thefts, 12 domestics, 10 disabled vehicles, 13 meet complainants and 79 alarms. Some notable incidents from the same are detailed below:

### MALL AND VICINITY

#### **Retail Theft**

**Sunglass Hut 160 N. Gulph Rd- occurred 5/15/18 at 1424 hours**

Employee stated a male actor took two pairs of sunglasses valued at \$1,600 and fled on foot into the mall.

#### **Theft Reports**

**Costco Wholesale 201 Allendale Rd- occurred 5/18/18 between 1130 and 1230 hours**

Unknown actor(s) stole an iPad from a parked/unlocked vehicle in the lot.

**Plaza Lot 160 N. Gulph Rd- occurred 5/21/18 between 1045 and 1300 hours**

Victim reported dropping her purse in the area of the Transit Center. The purse contained \$300 cash and various personal items. Surveillance video captured a female picking up the purse, and officers were able to locate the actor inside the mall. The actor admitted taking the purse and spending the money.

Employee reported \$40 cash and her SSI card missing from inside her purse, which was hanging on a hook in the 'employees only' room.

Victim is an employee who didn't realize her wallet was missing until later in the night. Victim checked with her bank and discovered two attempted and one successful fraudulent purchase(s) were made.
