FINANCIAL DISCUSSION

SWEDELAND PUMP STATION UPGRADE PROJECT (BID EXTENSION)

Lenni Electric Corporation & Klipper Construction Associates, Inc. has agreed to extend their bid proposal for approximately 60 days.

SEWER RATES

Sewer rates were reviewed approximately three (3) years ago and found to be very competitive with the surrounding municipalities. Sewer rates have been kept low minimizing costs to the residents.

If the Authority continues to put capital projects on hold, the more expensive they will become.

The rate increases in the past ten (10) years have been very low. All UMMUA funding received was used to fund certain capital projects at that time.

FINANCIAL DISCUSSION (CONT'D)

The Authority has to submit a recommendation for a flat rate increase to the Board of Supervisors for approval. This will help fund UMMUA capital projects going forward.

A presentation given by Executive Secretary and Finance Director will be presented to the Board of Supervisors regarding a sewer rate increase to help fund existing capital projects.

The Authority will schedule a meeting and give a presentation regarding an additional sewer rate increase to the Board of Supervisors in February or March 2014.
