

# Upper Merion Township Police



## Weekly Bulletin

**For the week ending on June 14, 2018**

Upper Merion Police Officers responded to 589 calls for service including 41 automobile crashes, 10 retail thefts, 9 domestics, 14 disabled vehicles, 15 meet complainants and 48 alarms. Some notable incidents from the same are detailed below:

### MALL AND VICINITY

#### **Retail Theft**

**H and M 160 N. Gulph Rd- occurred 6/7/2018 at 1235 hours**

An employee observed two female actors concealing merchandise in a bag and approached them. The actors fled on foot into the parking lot.
