Weekly Bulletin

For the week ending on July 12, 2018

Upper Merion Police Officers responded to 628 calls for service including 31 automobile crashes, 7 retail thefts, 5 domestics, 16 disabled vehicles, 12 meet complainants and 64 alarms. Some notable incidents from the same are detailed below:

MALL AND VICINITY

Theft Reports

Capital Grille 236 Mall Blvd- occurred 7/6/18 between 1745 and 2000 hours

Victim placed her purse on the back of her chair while dining with her husband. At some point during the evening an unknown actor(s) removed credit cards from her wallet and made unauthorized charges in excess of \$20,000.

LA Fitness 200 Village Dr- occurred 6/26/18 between 1630 and 1800 hours

Unknown actor(s) entered the unsecured lockers of four customers while they were working out, and stole various items from within.

Drug Arrest
