

# UPPER MERION TOWNSHIP POLICE



## WEEKLY BULLETIN

For the week ending on **November 16, 2017**

Upper Merion Police Officers responded to 505 calls for service including 46 automobile crashes, 5 Retail Thefts, 7 domestics, 13 disabled vehicles, 6 meet complainants and 46 alarms. Some notable incidents from the same are detailed below:

### MALL AND VICINITY
