WEEKLY BULLETIN

For the week ending on **November 23, 2017**

Upper Merion Police Officers responded to 517 calls for service including 34 automobile crashes, 9 Retail Thefts, 10 domestics, 8 disabled vehicles, 5 meet complainants and 71 alarms. Some notable incidents from the same are detailed below:
