## FINANCIAL REPORT

Mr. Hiriak reported on the remaining bond issue which matures next year September 1, 2016. The Township is in a position to prepay the bond issue on October 30, 2015 thereby saving the General Authority/Municipal Tax Building Fund approximately \$10,000 in interest.

Mr. Stuart asked the payoff amount. Mr. Hiriak responded the payoff amount is \$1.8 million. He indicated most of it is the bond issue for the Sewer Authority going back about 20 years ago which paid for sewer plant items and for items on the Township Building.

Mr. Kohler asked if the payoff would mean that the tax will come off the bill starting in 2016. Mr. Hiriak responded it is more likely the tax will be reallocated to another debt that has now been laddered. There are some administrative procedures that have to be followed and he indicated he does not see the tax going away.

Mr. Kohler asked if the tax had a sunset. Mr. Hiriak responded in the negative.

## **Authority Action:**

It was moved by Mr. Meneeley, seconded by Mr. Kohler, all voting "Aye" to proceed to pay off the debt as outlined in the amount of \$635,419.31. Motion approved 3-0.
