AN ORDINANCE AMENDING THE UPPER MERION TOWNSHIP ZONING CODE, CHAPTER 165, SECTION 165-160.2, TO REQUIRE THAT BUILDINGS IN THE KPMU DISTRICT CONTAINING DWELLING UNITS SHALL NOT EXCEED THIRTY PERCENT OF THE NET DEVELOPABLE AREA OF A PARCEL AND AMENDING SECTION 165-168, BUSINESS SIGNS, TO PROVIDE FOR KPMU SIGNAGE REQUIREMENTS

Section 1. Amends Chapter 165, as follows:

A. Amends Section 165-160.2, Use regulations, Table KPMU 1 Permitted Uses, related to the uses permitted in the KPMU-King of Prussia Mixed Use District, to amend Footnote 5 A thru H as follows:

- a. Establish a maximum residential density
- b. Establish a maximum building size
- c. Establish residential unit bedroom percentage
- d. Establish outdoor balcony requirements
- e. Provides for indoor bicycle storage
- f. Provides for short term outdoor bicycle storage
- g. Provides for individual unit laundry facilities
- h. Requires buildings with dwelling units to have common amenities
- B. Amends Section 165-168, Business Signs, to permit business signage, directory signage and light bands in the KPMU district.

- Section 2. Provides for a repealer clause
- Section 3. Provides for a severability provision
- Section 4. Provides for an effective date.
- Section 5. Provides for a Failure to Enforce provision.
- Section 6. Provides for an enactment date.
