 - Pass holder Update
 - o 2247 active members vs 2361 in August
 - o Daily visits 272 on weekdays vs 265 in August. 144 on weekends vs 128 in August
 - Free Passholder Program 7 families visiting are enrolled in the program. Only 6 families attending regularly. 1 family inactive for 2 months. They have been contacted.
 - 1 passholder expires in April, 4 expire at the end of November. There are 3-4 applications in waiting.

 - o Need more produce vendors.

 - 18 New Lifeguards lifeguard training offered

 - Discussion that 2 guests is not the right amount, and it should be bumped up to 3 guests.
 - o Swim meet nights in May closed to public
 - We don't have enough chaise lounge chairs getting estimated for better umbrellas.

 - UMCC pool is in good condition and does not need any major renovations.
