This letter provides notice of the decision of the Upper Merion Township Zoning Hearing Board following the conclusion of the hearing on Wednesday, September 20, 2023.

The Zoning Hearing Board voted to grant the application requesting a variance from section 165-168 in order to erect a sign on the rear building elevation.

This approval is based upon the strict compliance with the testimony and evidence presented at the hearing, in particular, the photo introduced as part of *Exhibit A-3* showing the proposed 60" x 146" Eigen X front lit channel letter sign for the rear entrance of the building.

Since this application was not contested, the Zoning Hearing Board will not issue a written decision with findings of fact, conclusions of law, and reasons.

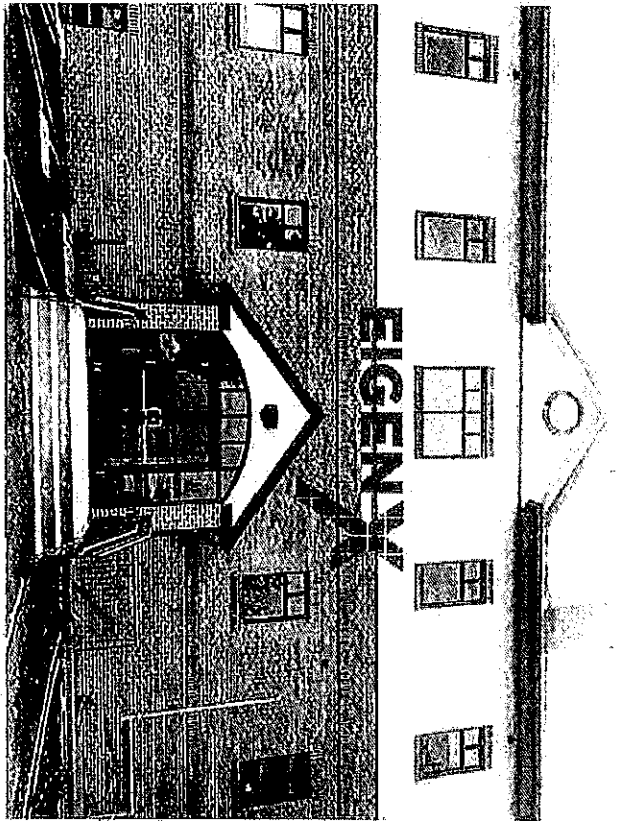

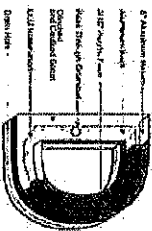

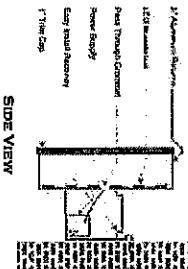
