#### Information for Discussion:

Swarthmore Borough has a more detailed Bamboo ordinance that provides for specific buffer area dimensions <u>https://codelibrary.amlegal.com/codes/swarthmore/latest/swarthm\_pa/0-0-0-22773</u>

New Britain Borough combined the standard Bamboo Ord with other invasive species (and included the list in the definition): <u>https://ecode360.com/32564719</u>

This would likely be the best way to address both. However, New Britain's provides for more regulation of existing plants, and not just planning new or permitting to spread. I think that is a consideration as to what level of regulation is desired for both bamboo and other invasive/noxious plants

In 2019, the STC did make a recommendation for the SALDO for an invasive species list that was incorporated under 145-24.1(L)(1) <u>https://ecode360.com/11657436#11657436</u> - so they do have a prior list to work from, although this would only apply through land development/subdivision so there would need to be another list to prevent non-land development plantings.
